GovRAMP Security Snapshot

Applicable for Products that have not yet achieved a GovRAMP Verified Status

- \$1,000 for Providers with less than \$1 M Annual Revenue
- \$1,500 for Providers with Annual Revenue between \$1 M - \$5 M
- \$2,500 for Providers with Annual Revenue greater than \$5 M

GovRAMP Progressing Security Snapshot (Subscription Option)

Applicable for Products that have not yet achieved a GovRAMP Verified Status; Includes Monthly Advisory Calls and Updated Quarterly Snapshots

- \$750 Monthly for Providers with less than \$1 M Annual Revenue
- \$1,000 for Providers with Annual Revenue between \$1 M - \$5 M
- \$1,600 for Providers with Annual Revenue greater than \$5 M

Annual Assessments

Annual PMO Assessment for GovRAMP Core Status

Applicable for any product as an early step in verified statuses, with no Third Party Assessing Organization (3PAO) audit required.

- \$9,000 for Providers with less than \$1 M Annual Revenue
- \$11,000 for Providers with Annual Revenue between \$1 M - \$5 M
- \$17,000 for Providers with Annual Revenue greater than \$5 M

Annual Ready Review for GovRAMP Ready Status

Applicable for products that have had a Third Party Assessing Organization (3PAO) conduct a Readiness Assessment Review (RAR).

- \$500 for Providers with less than \$1 M Annual Revenue
- \$2,500 for Providers with Annual Revenue between \$1 M - \$5 M
- \$3,750 for Providers with Annual Revenue greater than \$5 M

Annual Authorized Review for GovRAMP Authorized or Provisionally Authorized Status

Applicable for products that have had a Third Party Assessing Organization (3PAO) conduct a Security Assessment Review (SAR).

- \$1,500 for Providers with less than \$1 M Annual Revenue
- \$5,000 for Providers with Annual Revenue between \$1 M - \$5 M
- \$7,500 for Providers with Annual Revenue greater than \$5 M

Continuous Monitoring

Quarterly Continuous Monitoring for Core

Applicable for Products with Core Status.

- \$250 Quarterly **for** Providers with less than \$1 M Annual Revenue
- \$500 for Providers with Annual Revenue between \$1 M - \$5 M
- \$1,000 for Providers with Annual Revenue greater than \$5 M

Monthly Continuous Monitoring for Ready/Authorized

Applicable for Products with Ready, Authorized, or Provisionally Authorized Status.

- \$250 Monthly for Providers with less than \$1 M Annual Revenue
- \$500 for Providers with Annual Revenue between \$1 M - \$5 M
- \$1,000 for Providers with Annual Revenue greater than \$5 M

Note: PMO Fees may be subject to annual increases, not to exceed the published Bureau of Labor Statistics (BLS) annual percentage rate listed in June each year. Should there be any price adjustments, the PMO will notify the Board of Directors no later than September 1 of the year preceding the adjustment. Notifications of any price increases will be posted on the GovRAMP website no later than October 1, with an effective date being January 1 of the following year. If the PMO's requested price increases exceed those percentages outlined in the BLS for June of the current year, further Board approval shall be required prior to the increase.
